CONTRACT

(TOURING PENSION COLLECTIVE BARGAINING AGREEMENT WHEN COUNTER-INITIALED BY LOCAL UNION)

THIS CONTRACT for the personal services of musicians on the engagement described below, made this day of _____ 20 ____, between the undersigned Purchaser of Music (herein called "Employer") and _____ musicians. (including leader)

The musicians are engaged individually under the terms and conditions set forth in this contract. The leader represents that the musicians already designated have agreed to be bound by said terms and conditions. Each musician yet to be chosen, upon acceptance, shall be bound by said terms and conditions. Each musician may enforce this agreement. The musicians individually agree to render services under the undersigned leader.

6. A. When initialed by a representative of the Local Union in the space hereinafter provided, _____, this contract shall constitute a Collective Bargaining Agreement between the undersigned Employer (purchaser of music) and the Local Union covering the services of all musicians engaged under the terms of this agreement and during the period of the subject engagement only. Employer recognizes Local 257 as the sole and exclusive collective bargaining representative for all musicians engaged and employed under this agreement.

6. B. Upon completion of paragraph 6.A. above, this engagement is subject to contributions to the American Federation of Musicians and Employers' Pension Fund. The employer agrees to contribute an amount equivalent to _____ % of each employee's wages as set forth below in Appendix A of this agreement (which shall be considered to be scale wages) to the AFM-EP Fund. All contributions to the Fund shall be made by check payable to AFM-EP Fund and shall be accompanied by a remittance form for each employee for whom a contribution is made, the musician's name, social security number, date(s) of engagement for which pension is paid, scale wages on which pension is paid, and the amount of pension. The check and remittance information shall be transmitted to the local union for forwarding to the Fund within ten (10) days following the rendering of services for which such contributions are payable. The employer agrees to be bound by the Agreement and Declaration of Trust establishing The American Federation of Musicians and Employers' Pension Fund, as it may be amended from time to time, which is incorporated by reference into this Agreement.

7. No performance of the engagement shall be recorded, reproduced or transmitted from the place of performance, in any manner or by any means whatsoever, in the absence of a specific written agreement with the Federation relating to and permitting such recording, reproduction or transmission.
